

Debt-for-Health Swap Templates

Document Purpose: This set of templates facilitates debt-for-health swaps under the *Planetary Health Accord Implementation Framework*, enabling low- and middle-income countries (LMICs) to redirect debt repayments toward equitable health initiatives. The templates support negotiations, project planning, and monitoring, ensuring alignment with the Global Health Equity Council, Regional Health Hubs, and Community Health Legions. They are designed for policymakers, financial managers, regional coordinators, community leaders, and health advocates to implement transparent, inclusive debt relief mechanisms that advance health equity.

Cultural Competency and Equity Considerations

The templates prioritize cultural safety, indigenous sovereignty, and equity.

- **Indigenous Sovereignty:**
 - Involve indigenous councils in proposal development and approval, per *Global Health Equity Council Setup Guide*.
 - Fund indigenous-led health initiatives, respecting traditional practices (*Cultural Competency Training Module*).
 - Protect indigenous data in financial transactions, per *Blockchain Health Records Setup Guide*.
- **Language Justice:**
 - Provide templates in UN official languages, local dialects, and indigenous languages.
 - Offer sign language, audio formats, and braille for accessibility.
 - Train facilitators in multilingual communication.
- **Gender and Disability Inclusion:**
 - Prioritize funding for gender-specific and disability-focused programs (e.g., maternal health, accessible clinics).
 - Ensure diverse representation in proposal review teams.
- **LMIC and Marginalized Communities:**
 - Allocate minimum 60% of swapped funds to LMIC and marginalized groups (e.g., refugees, LGBTQ+).
 - Simplify proposal processes for low-resource settings, with technical support.
- **Community-Centric Approach:**
 - Engage communities in needs assessments and monitoring, per *Community Engagement Toolkit*.
 - Respect traditional financial practices (e.g., community-based funding models).
