### Mobile Clinic Principles

---

The kit is grounded in the following principles:

- **Accessibility:** Deliver healthcare to remote and underserved populations.

### Planning and Setup

---

#### Steps

##### 1. Needs Assessment (1-2 Months):

- Identify target areas using health data, per *One Health Surveillance Protocols*.

- Assess community needs (e.g., maternal care, vaccinations) via *Community Engagement Toolkit*.
- Engage indigenous councils and youth for input, per *Youth Advisory Board Framework*.

## 2. Clinic Design and Funding:

- Design mobile units (e.g., vans, trailers) with solar power and medical equipment for low-resource settings.
- Secure funding via *Health Solidarity Fund Setup Guide*, *Debt-for-Health Swap Templates*, or *Health Impact Bond Framework*.

## 3. Logistics Planning:

- Map routes prioritizing high-need areas (e.g., rural LMIC).
- Establish supply chains for medicines and equipment, per *Open-Source Pharma Toolkit*.
- **Staffing:**
  - Recruit and train health workers, per *Community Health Legion Training Manual*.
  - Include mental health and trauma specialists, per *Mental Health Integration Toolkit*.
- **Outcome:** 5 mobile clinics planned with routes, funding, and staff.
- **Timeline:** 3-2 months.

## Operations and Service Delivery

Efficient operations ensure high-quality healthcare.

### Key Strategies

- **Service Offerings:**

  - Stock clinics with open-source pharmaceuticals, per *Open-Source Pharma Toolkit*.
