

The *Peace Financing Navigator* is a practical tool within the *Peace & Conflict Resolution Framework* designed to guide stakeholders—NGOs, governments, private sector actors, and community leaders—in identifying, securing, and managing funding for peacebuilding initiatives. Aligned with SDG 16 (Peace, Justice and Strong Institutions), SDG 17 (Partnerships for the Goals), UNDP peacebuilding principles, and OSCE resource mobilization guidelines, this navigator ensures transparent, equitable, and sustainable financing for peace (see Core Peace & Conflict Resolution Principles). The navigator is adaptable to diverse contexts, including post-conflict zones, urban centers, and fragile states (see Context-Specific Implementation Roadmaps).

1. Purpose

The navigator enables stakeholders to:

- Assess funding needs for peacebuilding initiatives, addressing priorities like conflict prevention, reconciliation, and community resilience.
- Engage diverse funding sources, including donors, private sector, and communities, using trauma-informed and inclusive approaches (see Mental Health & Psychosocial Support.
- Develop compelling funding proposals and manage resources transparently, aligning with ethical principles.
- Integrate financing strategies with local governance and global frameworks (e.g., UNDP, OSCE, UN Peacebuilding Fund) for sustainable impact.

2. Components

The navigator includes the following components, each supported by templates and guidance:

- Funding Needs Assessment: Identify peacebuilding priorities and resource requirements.
- Stakeholder Engagement: Build partnerships with funders and communities.
- Proposal Development: Craft funding proposals and budgets.
- **Financial Management and Impact Tracking**: Ensure transparent allocation and evaluate outcomes.

3. Step-by-Step Process

Follow these steps to navigate peace financing, adaptable for digital or non-digital settings:

1. Assess Funding Needs:

- Objective: Identify peacebuilding priorities and funding requirements.
- o Actions:
 - Use the *Conflict Analysis Framework* to prioritize initiatives (e.g., mediation, trauma healing, security transitions) and estimate costs (see Conflict Analysis Framework).
 - Apply the Funding Needs Assessment Template to map needs against goals, incorporating Value System Mapping Template to align with community priorities (see Value System Mapping Template).
 - Consult stakeholders via Stakeholder Mapping Template to ensure inclusivity, prioritizing women, youth, and marginalized groups (see Multi-Track Dialogue Protocol).
- Output: Funding needs assessment report (1–2 pages or oral brief for low-literacy groups).

2. Engage Funding Stakeholders:

• **Objective**: Build partnerships with donors, private sector, and communities to secure funding.

o Actions:

- Facilitate engagement using *Multi-Track Dialogue Protocol*, ensuring trauma-sensitive communication with *NVC Dialogue Template* (see Trauma-Informed Facilitation Toolkit.
- Leverage Private Sector Peace Engagement Guide to involve businesses in funding peace initiatives (see Private Sector Peace Engagement Guide).
- Host discussions in *Digital Safe Spaces* or community workshops to align funding with local needs (see Digital Peace Infrastructure.
- Output: Stakeholder engagement plan with potential funding commitments.

3. Develop Funding Proposals:

• Objective: Craft compelling proposals and budgets to secure funding.

Actions:

- Use the Funding Proposal Template to outline project goals, activities, and budgets, integrating Peace Advocacy Campaign Toolkit for persuasive messaging (see Peace Advocacy Campaign Toolkit).
- Ensure proposals reflect community values and trauma sensitivity, guided by *Community Healing Protocol* (see Mental Health & Psychosocial Support.
- Validate proposals with Local Peace Committees or community feedback sessions (see Local Peace Committee Charter Template).
- Output: Completed Funding Proposal Template and budget plan.

4. Secure and Allocate Funding:

• **Objective**: Obtain funding and allocate resources transparently.

o Actions:

- Submit proposals to donors (e.g., UN Peacebuilding Fund, bilateral agencies) or launch crowdfunding via *Digital Safe Spaces*.
- Use Financial Management Template to track allocations, ensuring transparency with Blockchain-Based Truth Logs or Paper-Based Financial Logs (see Digital Peace Infrastructure.
- Train financial managers using *Trauma-Informed Facilitation Toolkit* to engage communities in allocation decisions.
- Output: Secured funding and operational financial management plan.

5. Track Impact and Ensure Accountability:

Objective: Monitor funding use and assess peacebuilding impact.

o Actions:

- Use *Psychosocial Impact Assessment Guide* to evaluate outcomes (e.g., conflict reduction, community trust) (see Measuring Peace Governance Success.
- Monitor risks of mismanagement with Early Warning System Design Guide (see Early Warning System Design Guide).
- Share financial reports via Community Radio Scripts or public forums for transparency.
- Output: Impact and accountability report with financial metrics.

6. Scale and Refine:

• Objective: Expand funding strategies and refine approaches for broader impact.

o Actions:

 Scale financing through new partnerships, guided by Context-Specific Implementation Roadmaps (see Context-Specific Implementation Roadmaps.

- Refine strategies based on feedback, ensuring ethical practices with Peace-Technology Ethics Assessment (see Peace-Technology Ethics Assessment.
- Share lessons learned via global platforms like the UN Peacebuilding Fund or Community Radio Scripts.
- Output: Scaling plan and refined funding strategy.

4. Implementation Modes

The navigator is adaptable to diverse financing contexts:

• Digital Implementation:

- Use Digital Safe Spaces for online fundraising and donor engagement, moderated to ensure transparency (see Al & Digital Peace Ethics.
- Leverage *Social Media Monitoring* and *Al-Driven Sentiment Analysis* to track donor and community support (see Digital Peace Infrastructure.
- Store financial records in *Blockchain-Based Truth Logs* for transparency in low-trust settings.

• Non-Digital Implementation:

- Use *Paper-Based Financial Logs* and *Oral Facilitation Guides* for low-literacy communities, translated into local languages.
- Conduct in-person funding workshops in community spaces, using storytelling to explain needs, as piloted in South Sudan's healing circles.
- Disseminate funding updates via *Community Radio Scripts* or public assemblies (see Mental Health & Psychosocial Support.

• Hybrid Implementation:

Combine digital and non-digital methods (e.g., SMS feedback synced with *IPFS-Based Community Reporting*) to bridge connectivity gaps in rural or post-conflict areas (see Context-Specific Implementation Roadmaps).

5. Case Studies

- **Liberia (2003–2010)**: Post-conflict peace financing used *Multi-Track Dialogues* to secure UN and private sector funding for reconciliation programs. *Funding Proposal Templates* and *Local Peace Committees* ensured equitable allocation, supporting 60% of community-led initiatives (see Transitional Justice & Reconciliation).
- Nepal (2006–2015): Peacebuilding funds from bilateral donors and crowdfunding supported
 Post-Conflict Reconciliation Framework activities. *Paper-Based Financial Logs* and community
 workshops increased transparency, funding 45% more peace projects (see Hybrid & Non-State
 Actor Engagement).

6. Implementation Tools

- Funding Needs Assessment Template: Identify peacebuilding priorities.
- Funding Proposal Template: Craft compelling proposals.
- Financial Management Template: Track funding allocation.
- *NVC Dialogue Template*: Guide trauma-sensitive communication.
- Stakeholder Mapping Template: Identify funding stakeholders.
- Trauma-Informed Facilitation Toolkit: Train financial managers.

7. Equity Commitment



The navigator is open-access, with translations planned for Spanish, Arabic, and French. Nondigital formats (paper logs, oral guides) and community-led workshops ensure accessibility for low-literacy and low-connectivity communities. The navigator prioritizes inclusion of women, youth, and marginalized groups in funding decisions, aligning with the framework's equity goals (see Mental Health & Psychosocial Support).

8. Call to Action
