Framework Overview

Purpose

- **Local Dialogue Circles:** Facilitate community-level discussions, feeding insights to higher levels.
- **Implementation Tools:** Practical guides and templates for dialogue facilitation, documentation, and policy translation.

Process

1. **Dialogue Facilitation:** Structured conversations identify shared values and commitments, using tools like the [Dialogue Facilitation Guide](#).
2. **Value Mapping:** Synthesizes ethical principles across traditions, per the [Cross-Tradition Values Mapping Tool](#).

3. **Outcome Documentation:** Archives insights and commitments, using the [Wisdom Documentation Templates](#).
4. **Policy Integration:** Translates outcomes into policies, via the [Policy Translation Guide](#) and [Policy Development Guide](#).
5. **Monitoring and Feedback:** Tracks impact and refines processes, using the [Representation Metrics Dashboard](#) and [Digital Feedback Dashboard](#).

Application in Policy Contexts

- **Cultural Preservation:** Support policies protecting sacred sites, informed by Indigenous dialogues in Australia.

- **Policy Impact:** Coastal conservation policy drafted using the [Policy Development Guide](#), increasing protected marine areas by 10% by 2026.
